



GIST OF THE TARIFF ORDER DATED 06.06.2024 FOR THE YEAR 2022-23
ISSUED BY THE WEST BENGAL ELECTRICITY REGULATORY COMMISSION
IN CASE NO. TP-100/22-23 IN RESPECT OF ADHUNIK POWER
AND NATURAL RESOURCES LIMITED

1. In terms of the West Bengal Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2011, as amended from time to time, the West Bengal Electricity Regulatory Commission (in short "Commission") vide order dated 06 June, 2024 in Case No. TP-100/ 22-23 has determined the Aggregate Revenue Requirement (ARR) of the Adhunik Power and Natural Resources Limited (in short "APNRL") and the revenue recoverable through tariff, capacity charge and energy charge for 2022-23 under the seventh control period in respect of 2x270 MW generating station of APNRL.

2. The annual capacity charge and energy charge recoverable by APNRL from its beneficiary i.e., WBSEDCL for 100MW share during 2022-23 shall be on the following basis :

(a) The annual capacity charge recoverable in line with the provisions of the Regulation 6.11.4 of the Tariff Regulations, as amended from time to time based on the availability duly certified by appropriate load despatch centre as given below :

(b) The energy charges recoverable shall be on the scheduled energy certified by SLDC as given below :

2022 - 23
Energy Charge in paisa/kWh
220.50

3. In addition to the energy charge, APNRL shall be further entitled to recover any variation in fuel cost through the Monthly Fuel Cost Adjustment (MFCA) formula specified in the WBERC Tariff Regulations, as amended from time to time.

4. The tariff shall be effective from 01.04.2022 and continue till further order of the Commission. However, any over / under recovery during the year 2022-23 shall be considered for adjustment during Annual Performance Review.

5. For merit order dispatch SLDC/ALDC shall consider the energy charge of the generating station of APNRL as determined in this tariff order prospectively along with applicable MFCA, if any, from the next day of issue of the order. APNRL and WBSEDCL shall provide the details of energy charge rate and the MFCA to the SLDC for merit order dispatch.

6. The applicable tariff and other associated terms and conditions of tariff of APNRL for 2022-23 is given in the Tariff Order dated 06 June 2024 which is available on the website of APNRL at <https://www.adhunikpower.com>.
